And since then, online classroom has been encouraged. Commenting on this development, Bozkurt, Jung, Xiao and Vladimrschi, (2020) affirmed that the physical absence of learners in the school during the covid-19 pandemic has led to a radical modification in the education of the learners and as a result the use of eLearning, online education and home schooling became popular at the time. Besides, other social media technologies such as WhatsApp, Facebook, zoom and the likes were also used. It is important to state that through some of these social media students were receiving content and instruction about what was to be learnt. These social media outlets have reasonable implications for education as discussed however, students must be guided if they are to use the social media for the betterment of their education otherwise the wrong usage of the social media would be inevitable.

and Instagram can be used to support both the teachers and the learners. Although the social technologies have proven to be useful in the teaching and learning processes, it is important to point out that it has its own limitations. One of such limitations is weak network connection. Without a good and a strong network, it will not be possible for one to make use of any social media technologies such as the Facebook, YouTube twitter and WhatsApp can be used to enhance educational processes and practices. The use of social media in education can also help improve the students learning motivation and performance and the attainment of educational goals.

#### Recommendations

- 1. Social media in the 21<sup>st</sup> century should be able to afford students and teachers opportunities to learn, not only in the classroom, through the interactive media that provides them with similar objectives from the comfort of their various homes.
- 2. Moderating the learners access to social media is one excellent way of curbing the negative use of social media as this will help in reducing the amount of time spent on harmful social network sites.

- 4. Providing ample time for face-to-face social interaction, like having some family leisure time in which individuals discuss their studies in a relaxed atmosphere or inviting friends and family over for get-together can help reduce the negative impact of social media on education as whole.
- 5. Educational institutions should incorporate social media in their mode of teaching and learning in order to arouse students' intellectual curiosity, their appetite for more learning and the development of critical thinking.
- 6. Schools should encourage teachers to use Google Classrooms and Face books to create pages for their classes so that they will serve as an open discussion boards where daily queries can be posted to encourage students to voice their opinions and join the conversation. So doing, it will improve learners' communication skills, participation, and knowledge acquisition and reduce the time they normally waste engaging in non educational activities on social media.

Teachers should be made to explore others networking sites such as pinterest for research where they can plan and organize research for students in a virtually appealing way and tiktok to post experiments and projects that are interesting and digestible.
