Editorial Policy Guidelines for contributions: Submission of Articles

- Manuscripts: The style of reference is mainly the TURABIAN method.
- Articles should not exceed 5000 words/15 pages (including abstract of not more than 250 words), typed on A4 paper with double line spacing using Times New Roman, Font size 12. Since Articles should be sent anonymously to consulting editors for assessment/peer review, the author's name, GSM's number(s), qualification, post and address should be typed on a separate detachable page.
- Quotations: Quotations that are 40 words and above should be properly indented with ½ inch margin to the left and right respectively.
- Articles submitted to any other body/Journal for publication or already published should NOT be sent to the Editor.
- On submission, three copies of the manuscript with the evidence of payment of vetting fee (N5000) should be sent to the Editor. This is only applicable to April version of the Journal.
- On the receipt of vetting article from the Editor, soft copy of the final manuscript after the necessary corrections should be submitted to the Editor with the publication fee.

This lack of cognitive resilience becomes especially problematic in academic or real-world settings where nuanced thinking is essential. Thus, while AI can support learning, it must be used judiciously to ensure it enhances rather than replaces the student's role in thinking critically and analytically.

Artificial intelligence also diminishes metacognitive skills. Metacognition—the ability to think about one's own thinking—is a cornerstone of critical thinking and effective learning. It

involves planning how to approach a task, monitoring one's understanding, and evaluating the effectiveness of learning strategies. With the increasing integration of Artificial Intelligence (AI) in education, there is growing concern that students' metacognitive skills may be weakening. AI tools that automate learning processes, recommend next steps, or provide instant solutions may reduce students' need to reflect on how they learn, ultimately diminishing their metacognitive engagement.

When students rely heavily on AI to decide what to study, how to solve problems, or when to review content, they may no longer practice essential self-regulatory behaviors. For example, an AI-powered platform might automatically generate study plans or suggest corrections without requiring the learner to assess their own understanding or learning gaps. While this automation can enhance efficiency, it deprives students of valuable opportunities to analyze their performance, set learning goals, or adjust strategies based on feedback. Over time, this leads to a passive learning experience where students become dependent on external guidance rather than cultivating the self-awareness and autonomy necessary for critical thinking. Diminished metacognitive skills can hinder students' ability to apply knowledge in unfamiliar or complex situations. Without the habit of self-monitoring and reflection, learners may struggle to adapt their thinking, troubleshoot problems, or evaluate the quality of their reasoning. As Holmes, Bialik, and Fadel (2019) caution, AI should be used in ways that support—not replace—the cognitive and reflective processes that help learners become self-directed thinkers. If educators do not actively promote metacognitive development alongside AI use, students risk losing a crucial skill that underpins their ability to think critically and learn independently.

Artificial Intelligence (AI) has made information more accessible than ever, offering students instant solutions, essay drafts, and even creative content generation. While this can aid learning, it also poses a significant risk to the development of original thought—an essential component of critical thinking. Original thought involves the ability to generate unique ideas, form independent opinions, and create novel solutions based on analysis and personal insight. When students consistently rely on AI-generated content, they may begin to substitute genuine thinking with replication, ultimately eroding their creative and analytical independence.

The ease with which AI provides ready-made responses can discourage students from engaging deeply with content. Rather than wrestling with complex questions, synthesizing knowledge, or forming arguments from their own understanding, learners may opt for AI-generated answers that appear complete and convincing. This habit of passively accepting information inhibits the practice of questioning, refining, and reconstructing ideas—processes that are crucial to developing a distinct intellectual voice. As students become more dependent on these tools, their ability to think divergently or offer fresh perspectives may gradually decline. The erosion of original thought undermines academic integrity and the growth of authentic problem-solving skills. Students who lean too heavily on AI may find it difficult to approach open-ended tasks without technological support, limiting their adaptability in both academic and real-world settings. Critical thinking requires not just evaluating existing information, but also contributing new insights to ongoing conversations. If learners are not consistently challenged to think for themselves, they risk becoming consumers of information rather than creators of knowledge—an outcome that can stifle both intellectual growth and long-term learning potential.

Conclusion

From the above discussion, it is worth noting that Artificial Intelligence offers valuable opportunities to enhance students' critical thinking through personalized learning, real-time feedback, and exposure to diverse perspectives. These tools can promote inquiry, reflection, and deeper engagement when used thoughtfully. However, the overuse or misuse of AI poses serious threats, including the erosion of original thought, reduced metacognitive development, and diminished analytical reasoning. Striking a balance between leveraging AI for support and encouraging independent thinking is essential for meaningful learning. Educators and students alike must approach AI as a complement to, not a replacement for, the human capacity to think critically and creatively.

Recommendations

- i. **Balanced Use of AI and Traditional Teaching:** Educators should integrate AI tools alongside conventional teaching methods to ensure students continue to develop critical thinking through human interaction and guided feedback.
- ii. **Critical Thinking-Centered AI Design:** Developers should design AI educational systems that actively promote analytical thinking, problem-solving, and decision-making skills.
- iii. **Educator Training and Support:** Teachers should receive proper training and support to effectively integrate AI tools into their teaching, enhancing their ability to nurture critical thinking.
- iv. **Continuous Assessment and Feedback:** Educators should use AI tools to regularly assess students' critical thinking and provide targeted, constructive feedback for improvement.
- v. **Emphasis on Ethics and Digital Literacy:** Teachers must promote ethical AI use and digital literacy, guiding students to critically evaluate AI-generated content, recognize biases, and understand its broader implications.
